ORDINANCE NO. 2021-15-0

AN ORDINANCE OF THE CITY COUNCIL OF LINDON CITY, UTAH COUNTY, UTAH, AMENDING THE LINDON CITY GENERAL PLAN STREET MASTER PLAN MAP THROUGH REMOVAL OF AN IDENTIFIED FUTURE STREET CONNECTION (280 W.) AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Council is authorized by State law to amend the Lindon City General Plan; and

WHEREAS, the Municipal Council of Lindon City finds it is necessary to amend portions of the Lindon City Street Master Plan Map, specifically the areas identified in Section 1; and

WHEREAS, the City finds that amending the General Plan Street Master Plan Map will still provide for a balanced traffic circulation system to meet the demands generated by the land uses in the area; and

WHEREAS, the proposed changes allow for additional property development; and

WHEREAS, the Planning Commission made a recommendation regarding the proposed amendment, and the amendment will continue to assist in carrying out general plan goals related to the creation of a balanced transportation system within the City; and


WHEREAS, on July 13, 2021, the Planning Commission held a properly noticed public hearing to hear testimony regarding an application to amend the General Plan Street Master Plan Map filed by Joe Martel; and

WHEREAS, after the public hearing, the Planning Commission further considered the proposed ordinance and recommended that the City Council adopt the recommended General Plan Street Master Plan Map amendment; and

WHEREAS, on <u>Olegust 16</u> the City Council held a properly noticed public hearing to hear testimony regarding the zoning map amendment and received and considered all public comments that were made therein.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Lindon City, Utah County, State of Utah, the Lindon City Street Master Plan is hereby amended as follows:

SECTION I - General Plan Street Master Plan Amendment: The Lindon City General Plan Street Master Plan Map is here by amended as follows:



SECTION II - Severability: The provisions of this ordinance and the provisions adopted or incorporated by reference are severable. If any provision of this ordinance is found to be invalid, unlawful, or unconstitutional by a court of competent jurisdiction, the balance of the ordinance shall nevertheless be unaffected and continue in full force and effect

SECTION III - Conflicting Provisions: Provisions of other ordinances in conflict with this ordinance and the provisions adopted or incorporated by reference are hereby repealed or amended as provided herein

SECTION IV – Effective Date: This ordinance shall take effect immediately upon its passage and posting as provide by law.
