

Ordinance No. 2023-3-O

AN ORDINANCE AMENDING SECTION 13.18.330 OF THE LINDON CITY CODE, REGARDING THE PRESSURIZED IRRIGATION SYSTEM, AND SETTING AN EFFECTIVE DATE.

WHEREAS, Lindon City has operated and maintained a pressurized irrigation system (also known as secondary water system) since the early 1990's; and

WHEREAS, Chapter 13.18 of the Lindon City Code was established to regulate the administration and operations of the pressurized irrigation system; and

WHEREAS, the State of Utah has recently legislated that all new connections to a secondary water system are required to have meters installed on existing and future connections, and Section 13.18.330 of Lindon City Code is therefore in conflict with State laws; and

WHEREAS, Lindon City is in process of installing meters on all existing pressurized irrigation connections and finds that Lindon City Code needs to be updated to conform with State laws and current city practices.

NOW THEREFORE, BE IT ORDAINED by the City Council of Lindon City, Utah, as follows:

PART ONE: Amendment of Chapter 13.18 of the Lindon City Code.

Section 13.18.330 of the Lindon City Code is amended as follows:

Water Meters.

~~Water meters shall not be installed at each Pressurized Irrigation water connection; provided, however, that the Council may determine that it is necessary to monitor water use through any Pressurized Irrigation water connection or combination of Pressurized Irrigation water connections.~~ Water meters shall be installed at each Pressurized Irrigation connection.


PART TWO: Severability.

Severability is intended throughout and within the provisions of this ordinance. If any section, subsection, sentence, clause, phrase or portion of this ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, then that decision shall not affect the validity of the remaining portions of this ordinance.


PART THREE: Effective Date.
